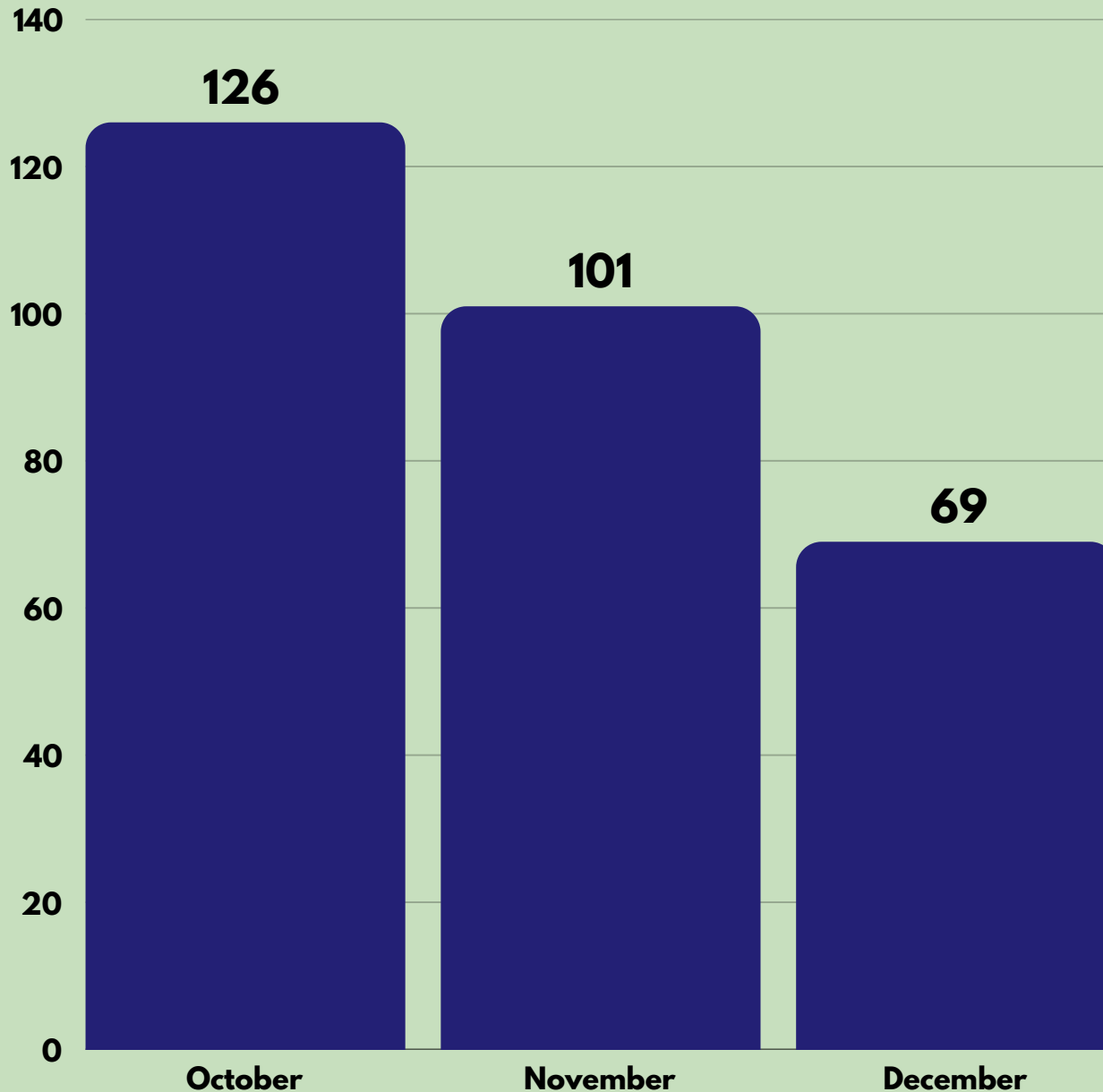

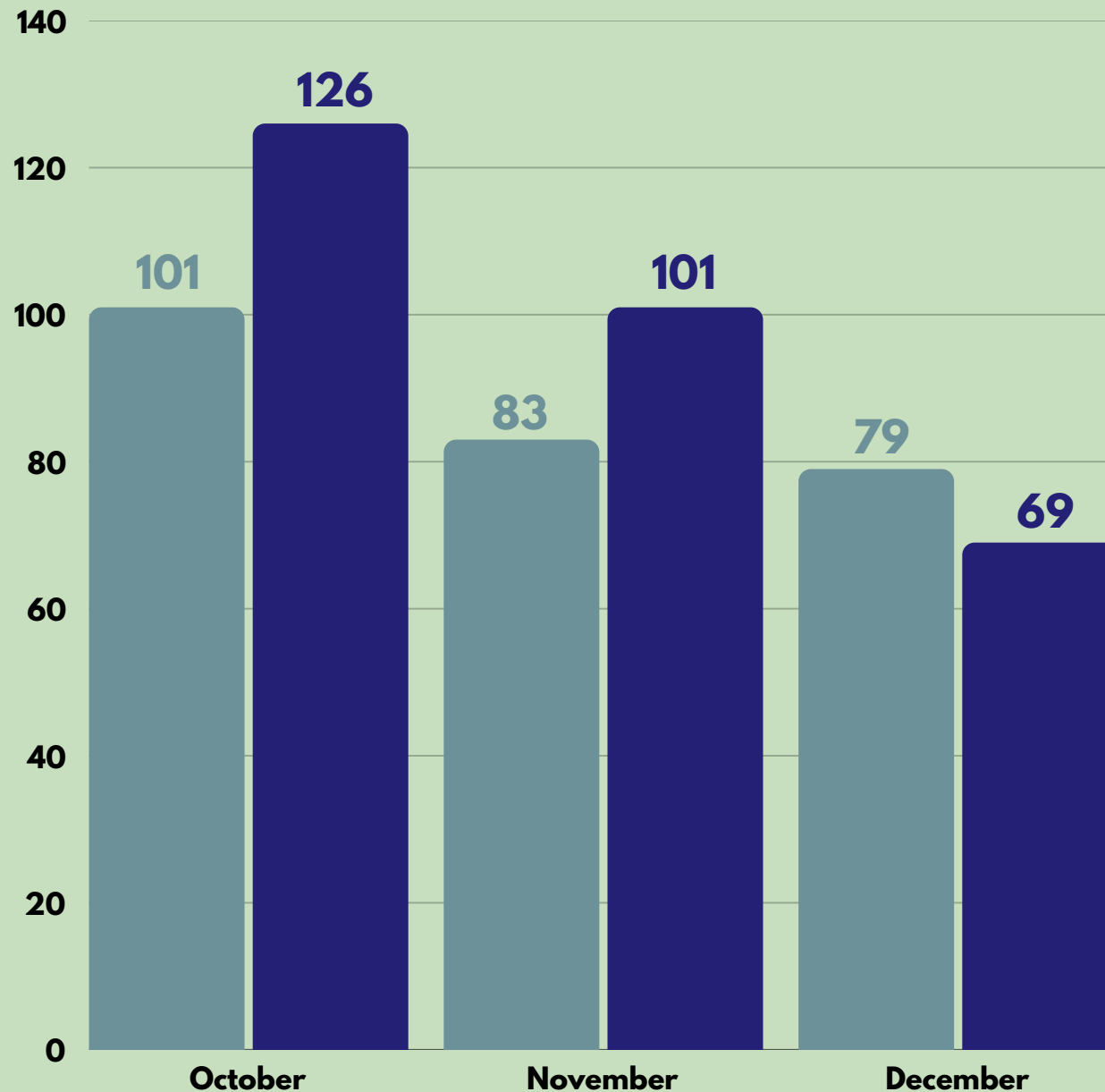

Overall rise in the no. of cases/month

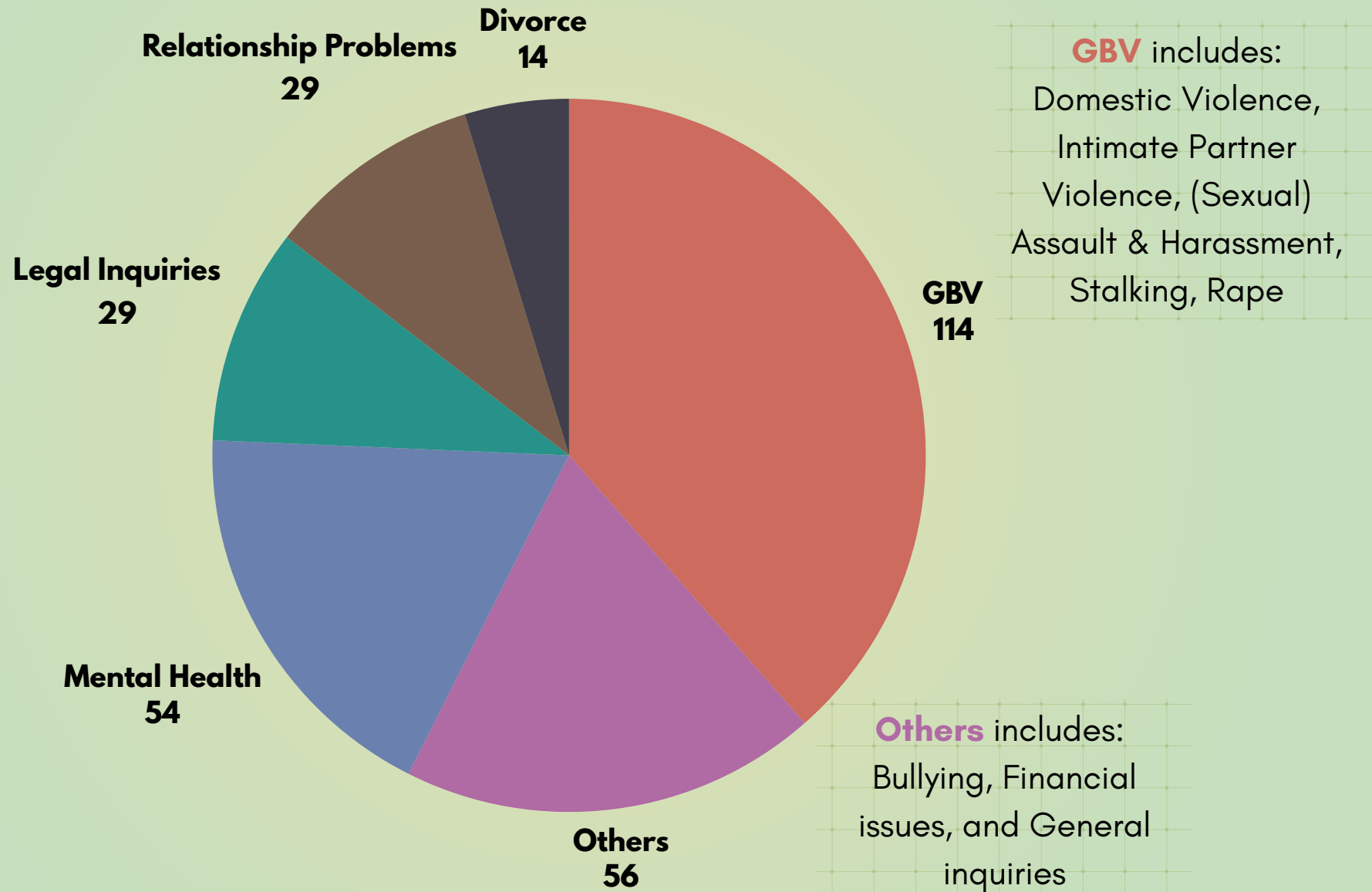

Total number of cases according to type



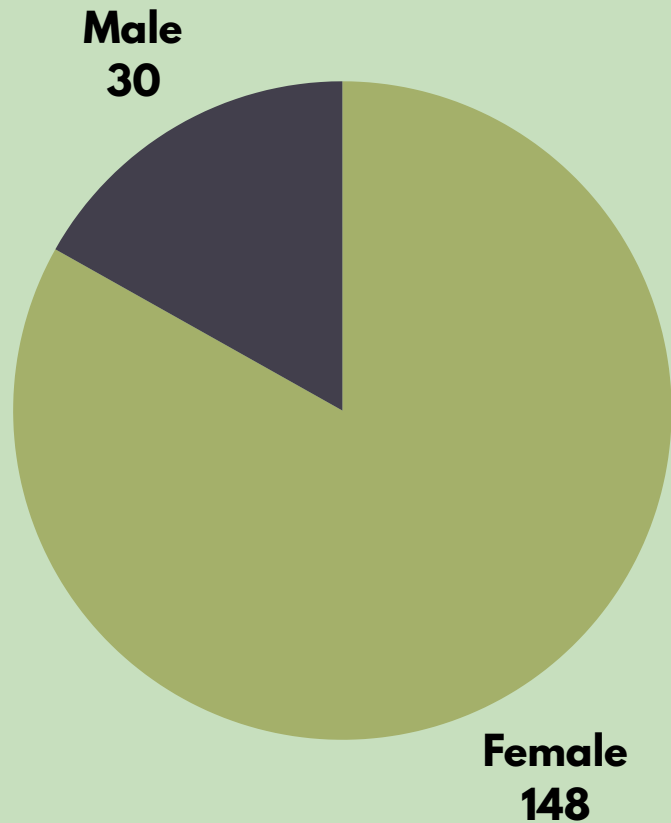

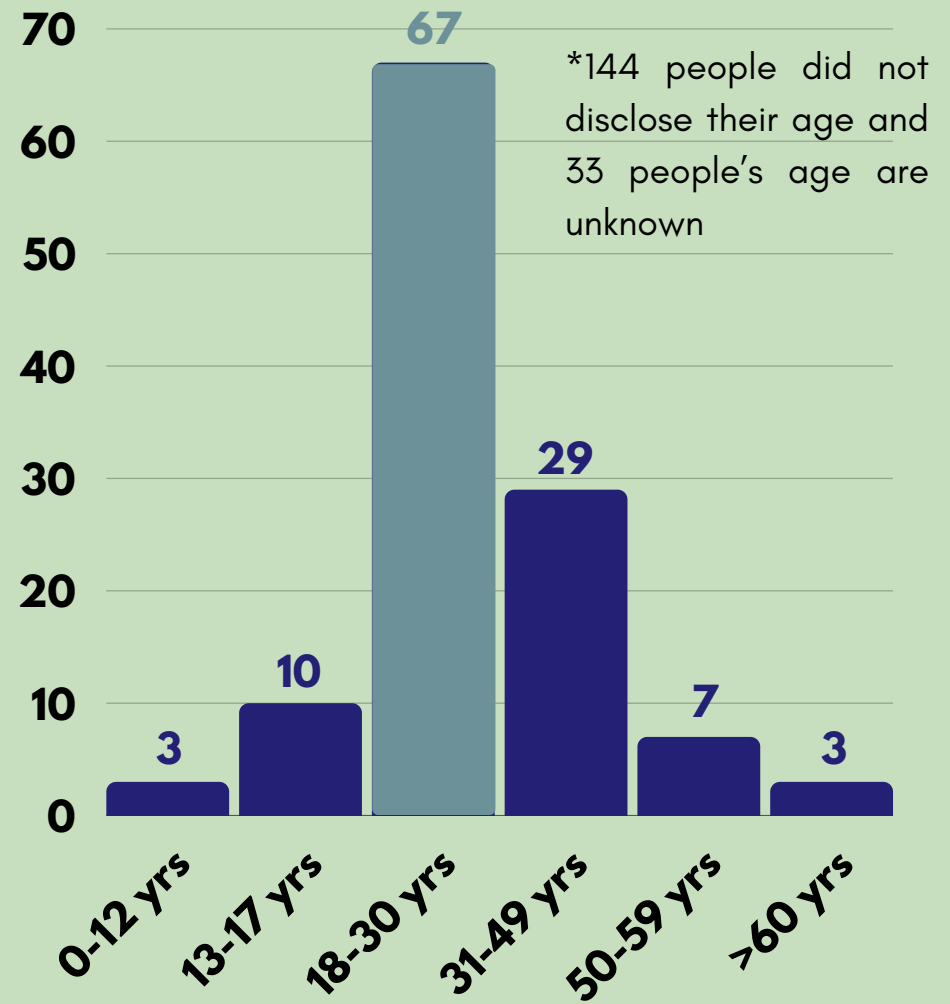

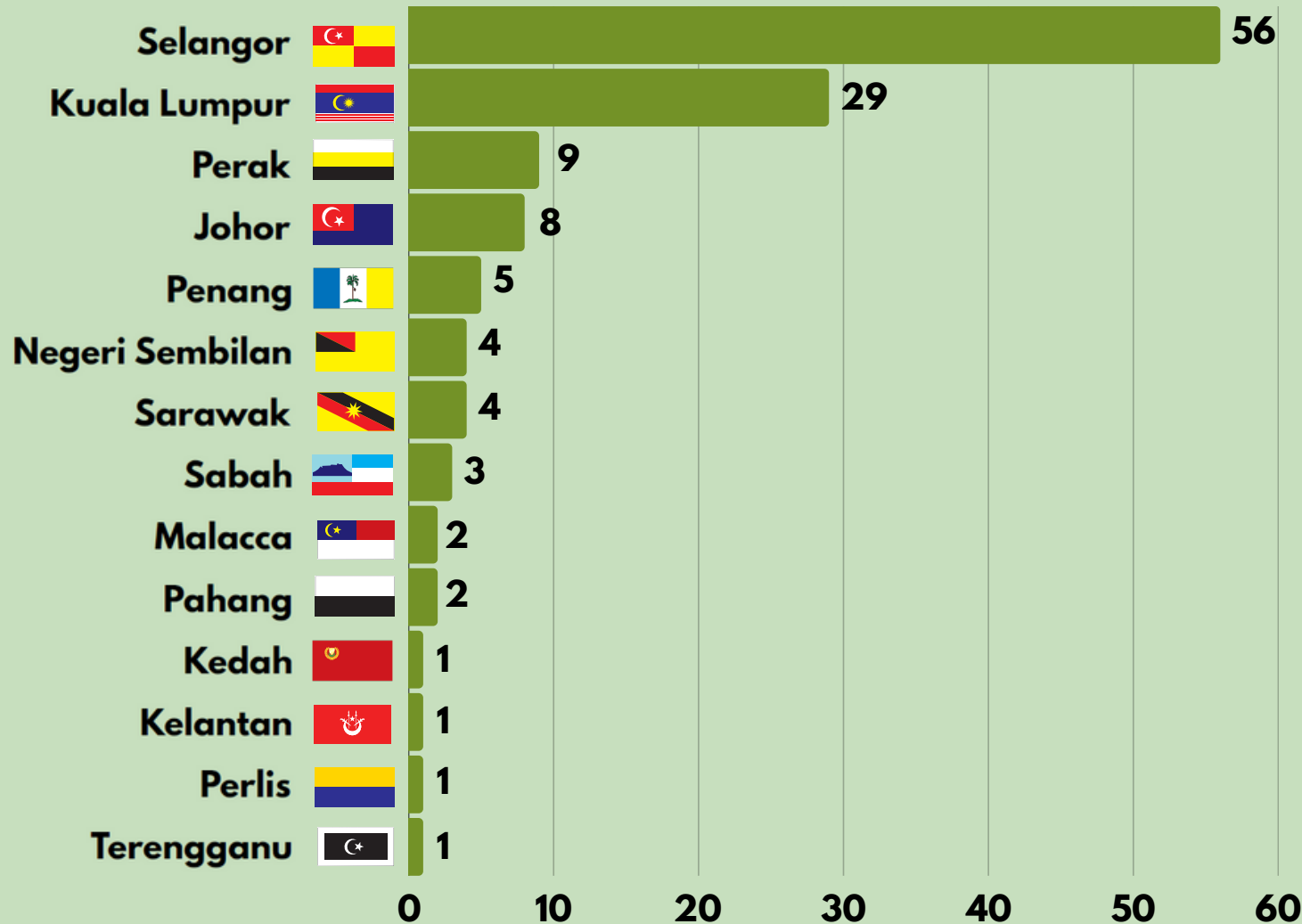

by state*



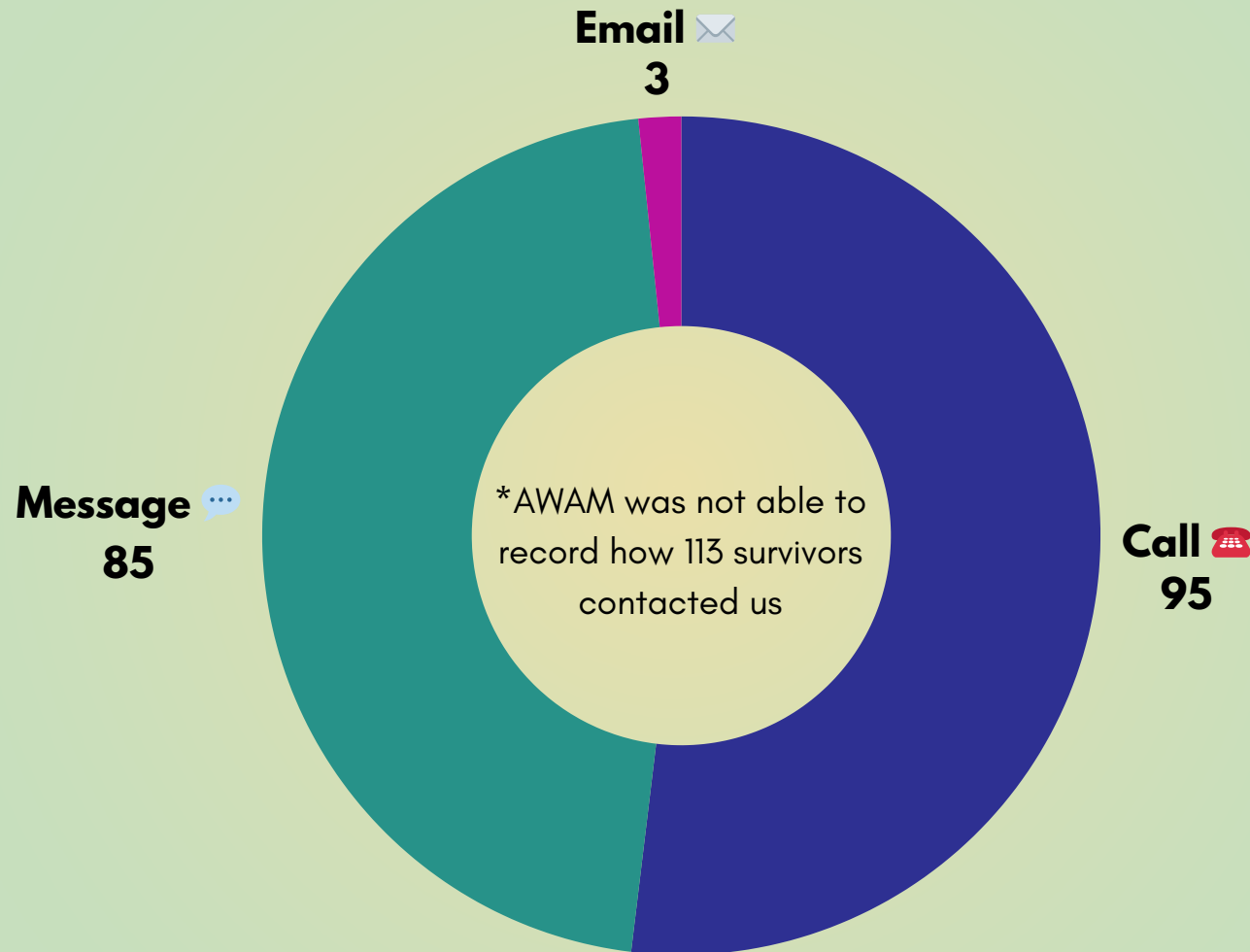

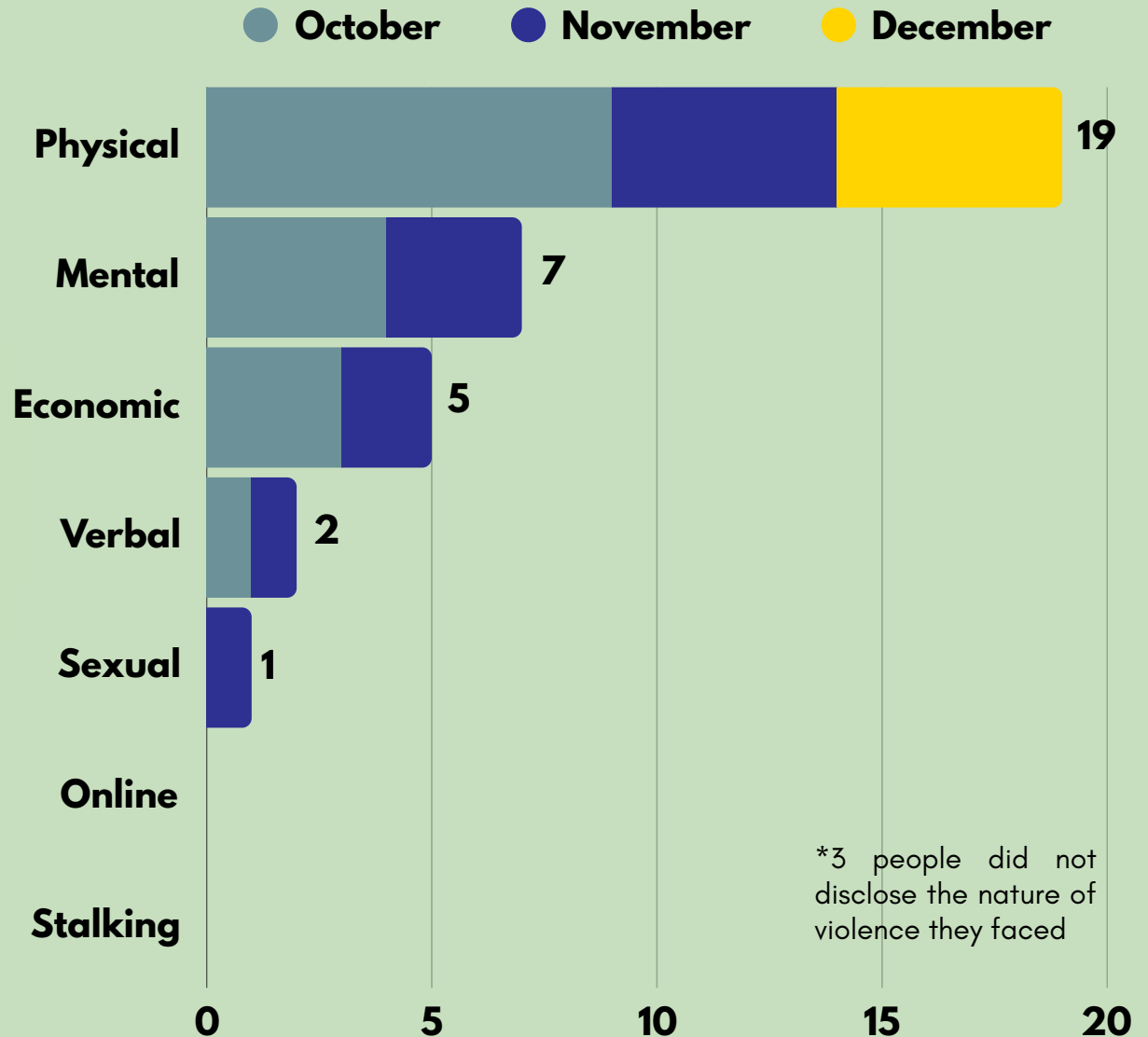

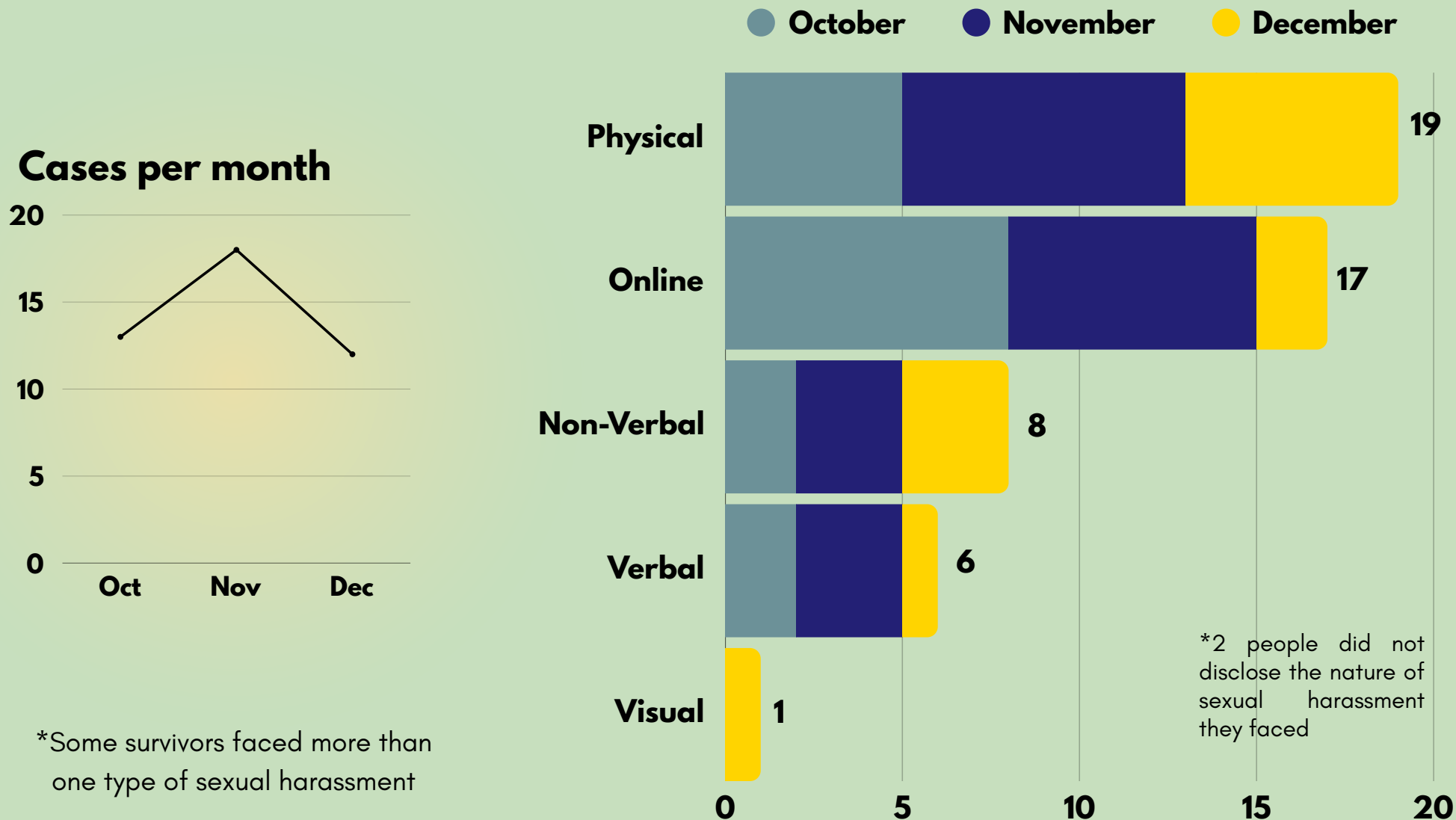
SEXUAL HARASSMENT

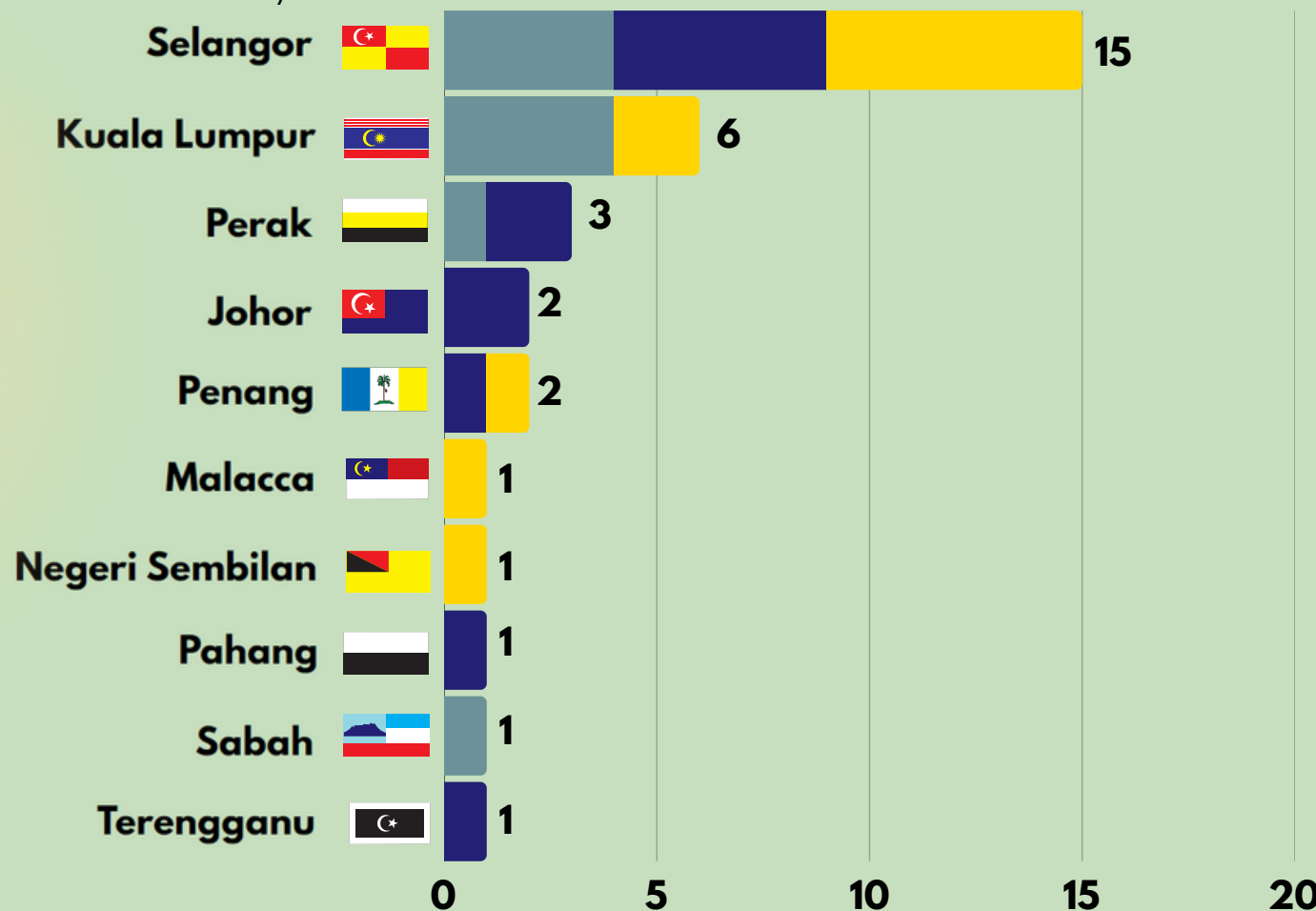

RAPE

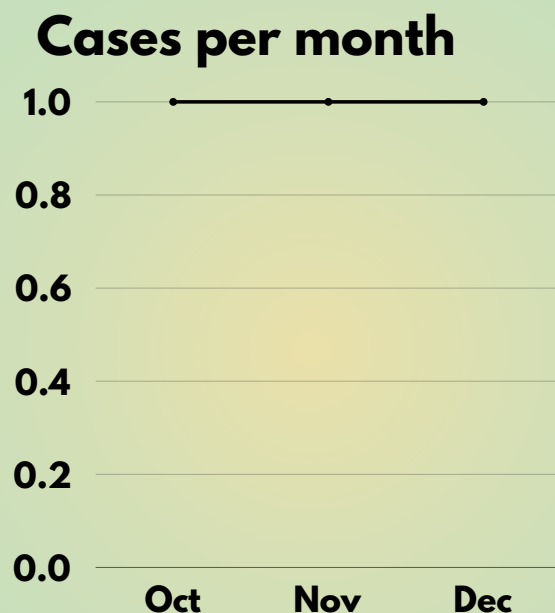
Sexual intercourse with a woman against her will or without her consent; or if consent was obtained by threat, coercion, or a power imbalance. Sexual intercourse with a girl under 16 years of age, with/without her consent, is also rape.

*The perpetrators included two ex-boyfriends and a 'sugar daddy.'

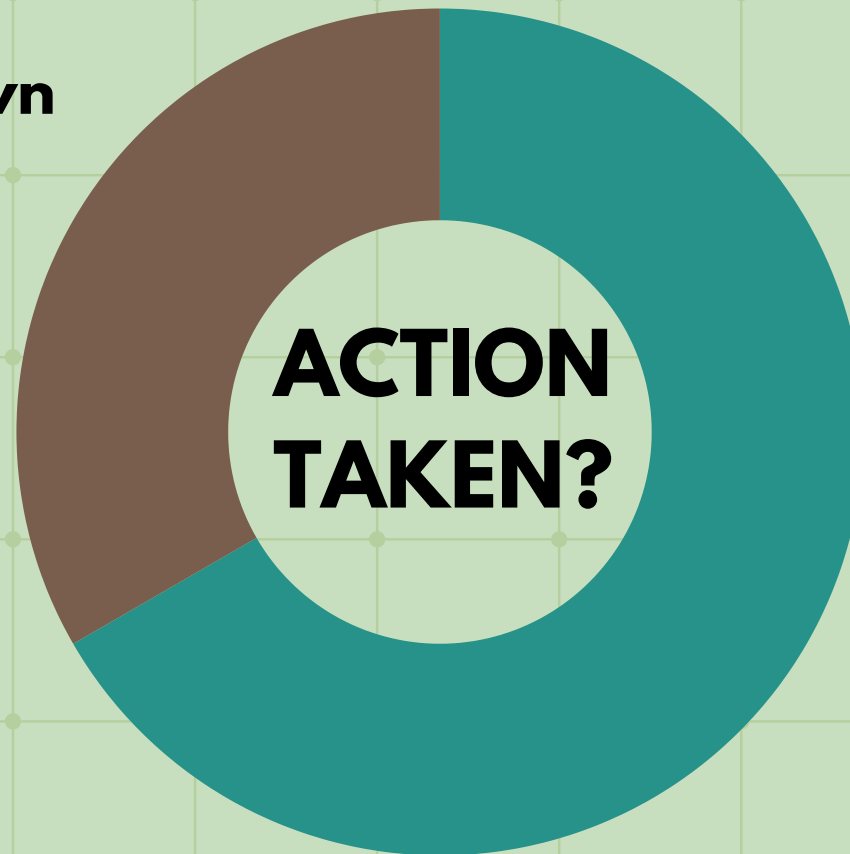


All three survivors are Malay. One is between 18 and 30 years old, and the remaining two survivors did not disclose their ages.

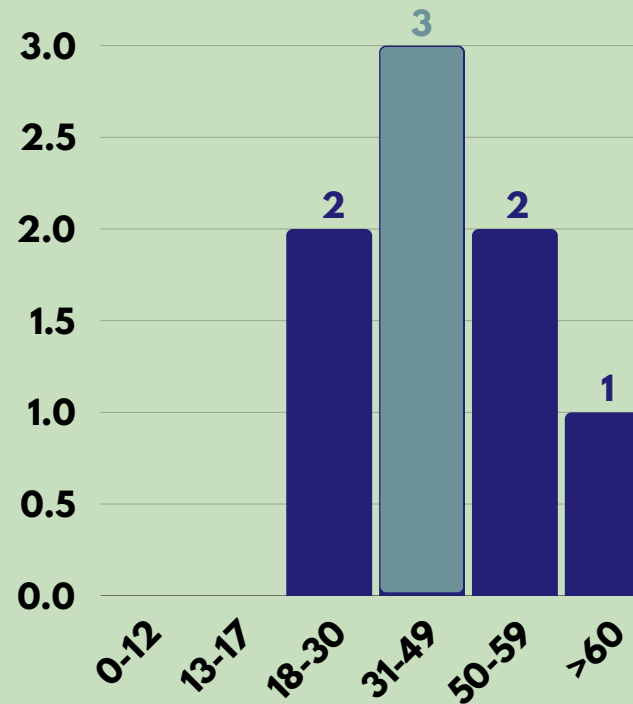

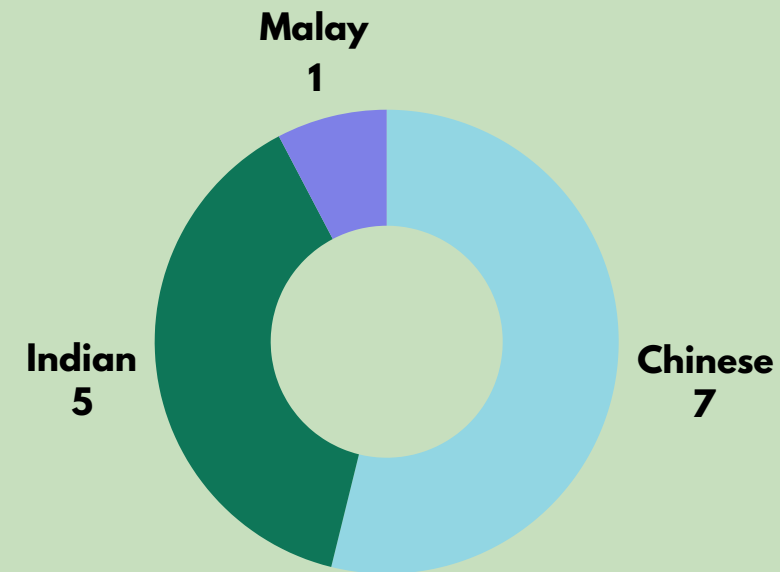

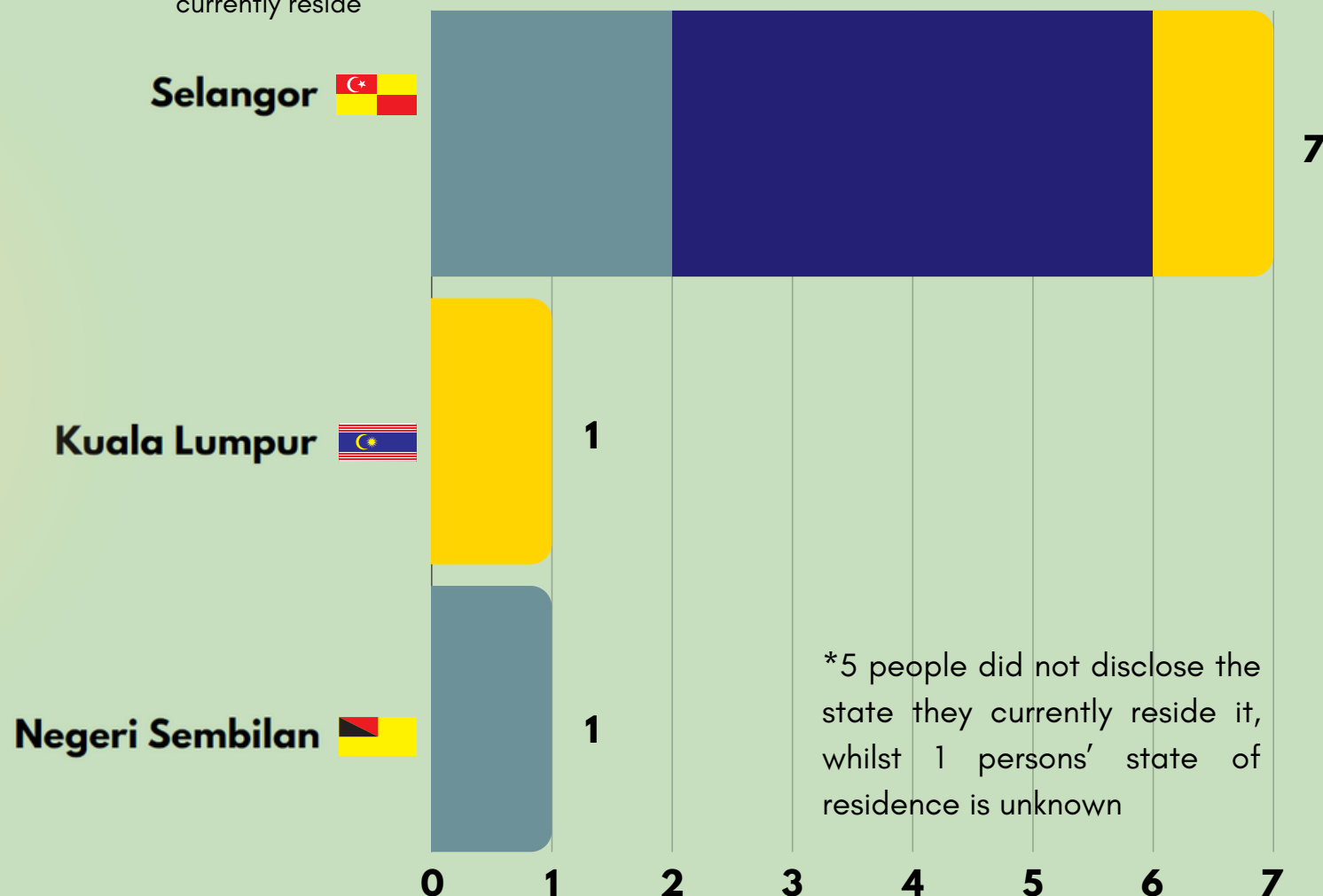

*Note: Telenita provides free counselling sessions. If a survivor requires professional attention, Telenita's counsellors will refer them to a psychiatrist or professional counsellor.

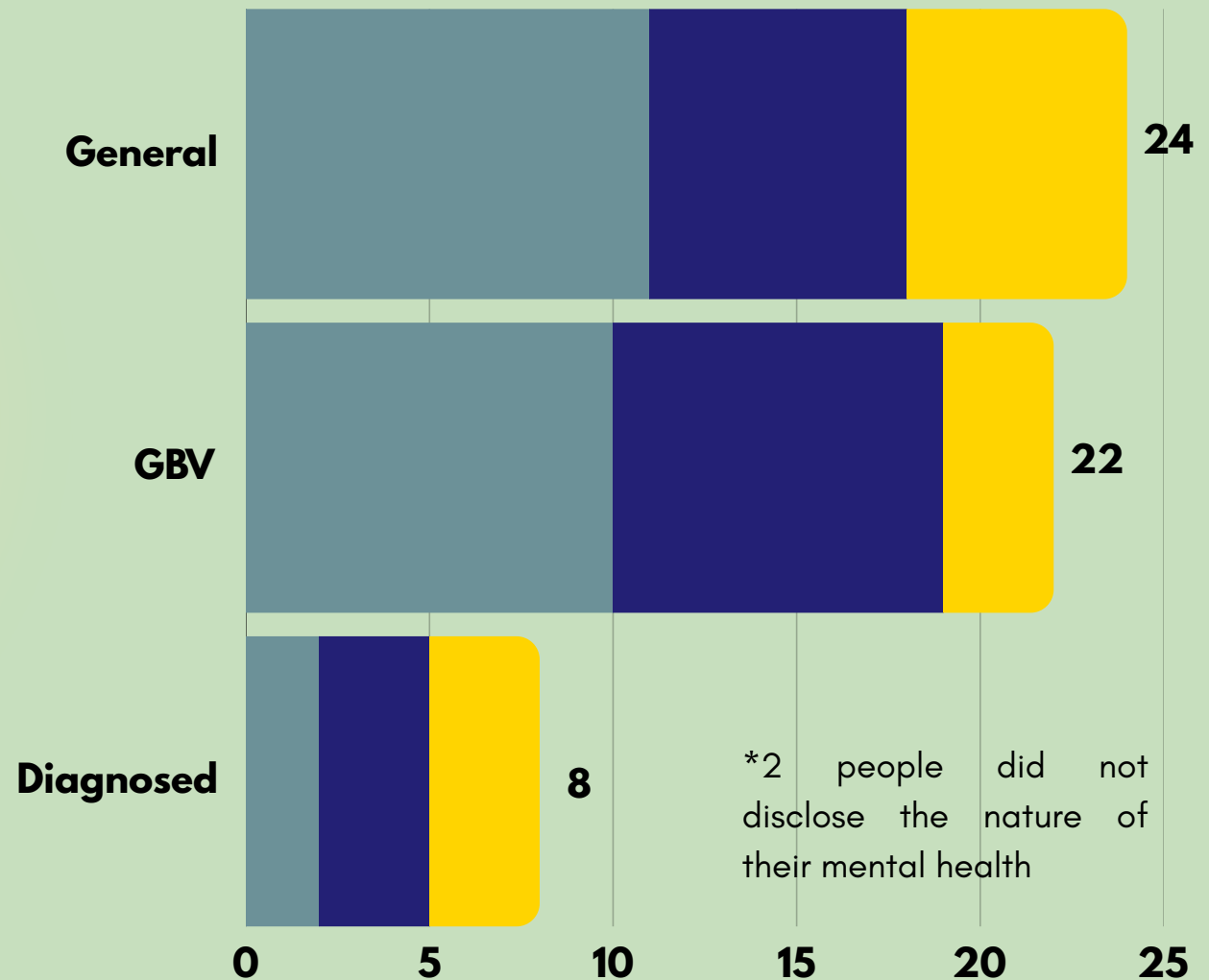

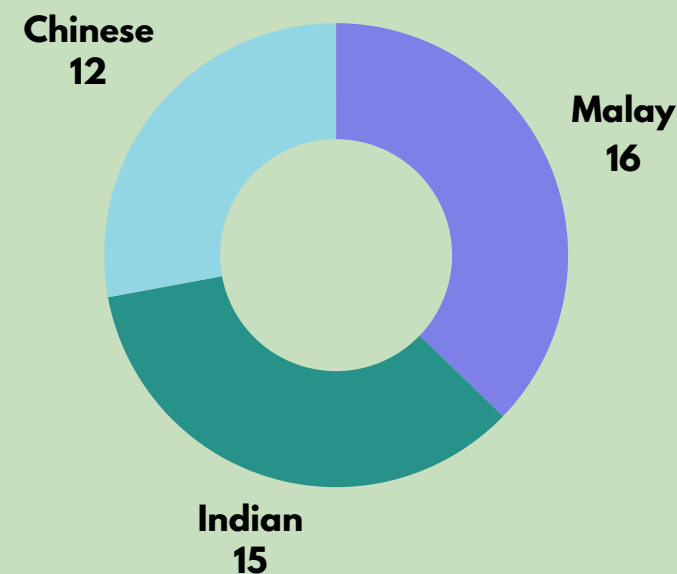

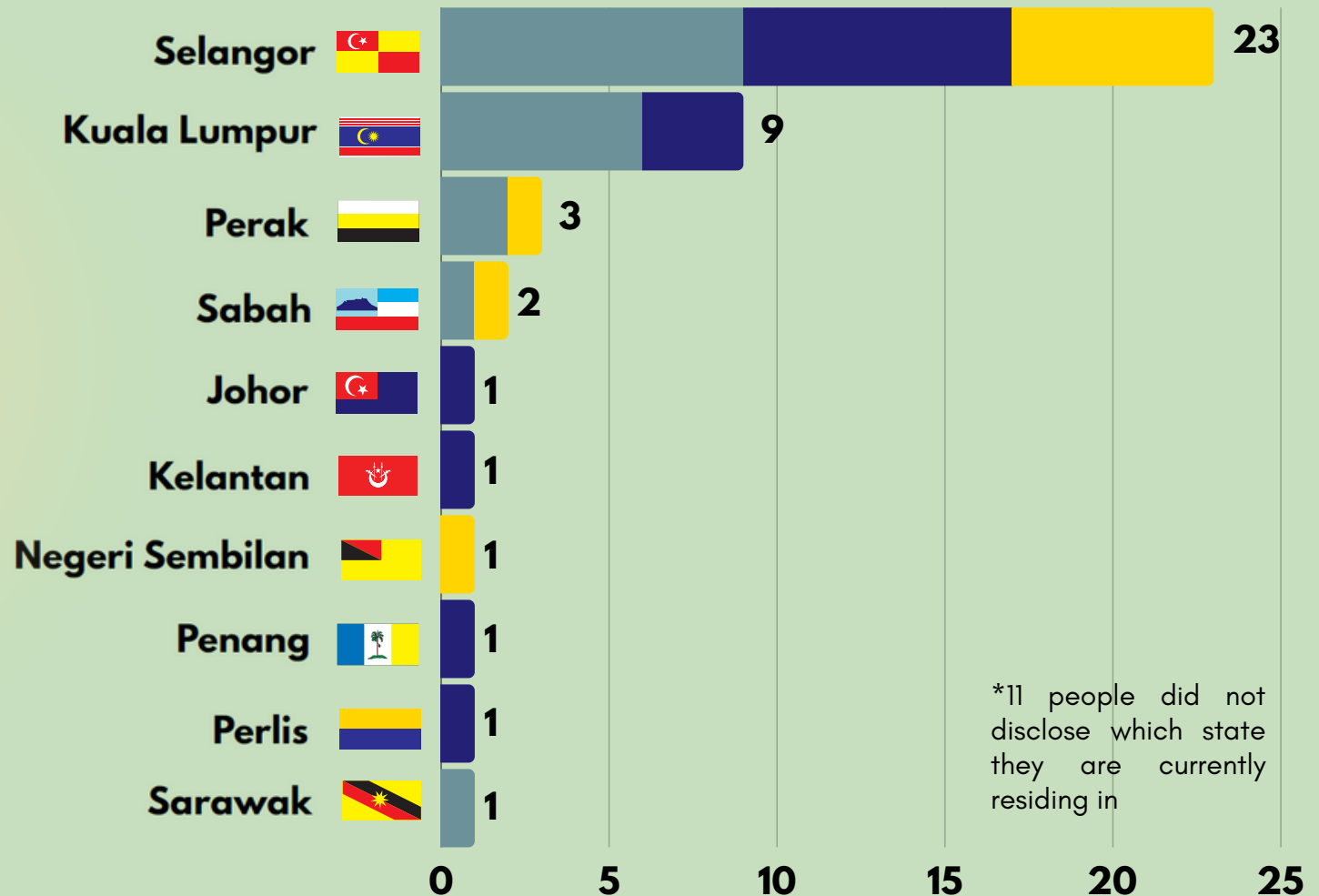
